Business Impacts

- ***Current state of homelessness in Tulsa impacting the business community we represent***
 - Concern for continued business investment based on an increase and more prevalent issues around homelessness from a safety standpoint.
- ***Availability and quality of housing impact on existing businesses and recruitment***
 - Previous recruitment activity traditionally had not considered housing in their factors of determination; however, we are starting to see more housing questions during the process.

Recommendations

- The business community is eager to be engaged and willing to be a part of the solution.
- Homelessness is a multifaceted issue, one that requires equal parts empathy and policy, and it's difficult to know where to start.
